2009 Convention Resolutions Proposed Resolutions for the 2009 Saskatchewan School Boards Association Annual General Meeting had been distributed. Mr. Don Hoium, Director of Education, noted that Board members would meet briefly following the Learning Alliance meeting with Saskatoon Public Schools to discuss same. Mr. Hoium also advised that, along with other Boards, Regina Public Schools would be participating in the Showcase Presentations on December 1st, highlighting Structural Innovation, Improving Outcomes for First Nations and Métis Students, and Innovation for Achievement.

Public Section Meeting Information regarding recent and upcoming meetings of the Public Section had been distributed. Dr. B. Young noted that the Public Section General Meeting scheduled for November 30th coincides with SSBA's Orientation for New Trustees. She recommended that Board members attend the Public Section meeting to receive litigation and mediation updates, and learn more about the Section's strategic plan and bylaws.

Continuous Improvement Plan 2009-10 Mr. Don Hoium, Director of Education, Mr. Ross Brown, Deputy Director, Instruction and School Services, and Ms. Debra Burnett, Deputy Director, Division Services, provided an overview of and responded to questions relative to the Continuous Improvement Plan 2009-10 that had been presented and approved at the September 15, 2009, Board meeting.

Final 2009-10 Budget Ms. Debra Burnett, Deputy Director, Division Services, provided an overview of and responded to questions relative to the Division's 2009-10 Final Budget that had been presented and approved for submission to the Ministry at the September 1, 2009, Board meeting. Ms. Burnett highlighted that, at the October 20, 2009, Board meeting, an increase of \$326,220 to budget revenues and expenditures had been approved in accordance with direction from the Ministry of Education.

Review of Board Work Plan (2009-10) The Board Annual Work Plan 2009-10, that had been presented and approved at the September 1, 2009, Board meeting, had been distributed. Mr. Don Hoium, Director of Education, provided a summary of the Work Plan, highlighting various regular Board meeting agenda items, accountability reports and events. Mr. Hoium noted that, with the delay of the Budget approval, certain accountability reports have been subsequently delayed, including the Continuous Improvement Plan and Report.

2009-10 Student Enrolment

Mr. Ross Brown, Deputy Director, Instruction and School Services, provided an update on student enrolment, including actual enrolment comparisons from 2006-07, 2007-08 and 2008-09. Mr. Brown noted the actual enrolment, as of September 30, 2009, is 20,308 students. He outlined that, of this total, 124 students are enrolled in more than one program and that 45 students are 22 years of age or older and pay tuition fees. As a result, total enrolment for funding purposes is 20,139 students. Mr. Brown also outlined that, prior to 2008-09, pre-kindergarten enrolment numbers were not included in the report. He advised that projected enrolments are ahead of schedule by one year, which could be attributed to an increase in students enrolling through the Newcomer Welcome Centre. In this regard, he advised that the Administration was discussing with the Ministry the impact of immigration on the Division.

Learning Alliance Meeting Proposal It had been proposed that a Learning Alliance meeting with the Saskatoon Board of Education be held prior to the start of the SSBA Fall Assembly in Saskatoon on Sunday, November 29, 2009. Mr. Don Hoium, Director of Education, noted that he would confirm these arrangements with the Saskatoon Board of Education and advise Board members accordingly.

High School Musical Mr. D. West advised that he had recently attended the high school musical, *The Wedding Singer*, at Sheldon-Williams Collegiate, and congratulated the staff and over 80 participating students, past and present, on a superb presentation.
