Self-Regulation Demonstration Classroom

Ms. Cathy Leugner, Principal, and Ms. Brenda Whittam-Neary, Intervention First Facilitator, provided an overview of the Self-Regulation Demonstration Classroom at Kitchener School. Ms. Whittam-Neary indicated that the goal of Tier 1 Intervention First is to create independent, self-regulated, and metacogntive learners. She emphasized the need to prepare students to learn, and that many children have regulation issues often misinterpreted as behavioural issues, that interfere with learning. She highlighted a variety of regulation techniques, including body repositioning, de-cluttering of classrooms, seating options, doodling, and chewing. Ms. Leugner concluded by noting that all teachers at Kitchener School are involved in promoting self-regulation. Board members expressed appreciation for the presentation.

Concept Plan/ Program Information: Adult Education Concept Plan

Information relative to the Adult Education Concept Plan had been distributed. Mr. Ross Brown, Deputy Director, Instruction and School Services, and Mr. Darren Boldt, Superintendent, Instruction and School Services, provided additional information, noting the need to provide educational opportunities to young adults who do not experience success in the normal course of high

school. Mr. Boldt noted the Concept Plan's correlation to the Continuous Improvement Plan priorities, with a focus on Smooth Transitions and Equitable Opportunities and Outcomes for All. He highlighted the emphasis on reclaiming youth-at-risk, providing post-secondary opportunities, and access to skilled trades and the world of work. Mr. Boldt outlined the alignment of programs and required supports, including the provision of learning intervention, counselling, addiction and child care services. Mr. Brown concluded by highlighting the success of the initiative and the progressive increase in graduation rates over the last four years. Board members expressed appreciation for the presentation.

Funding Model Principles

Information from the Saskatchewan School Boards Association, advising of the Ministry of Education's new Pre-K-12 Funding Distribution Model Guiding Principles, had been distributed. Mr. Don Hoium, Director of Education, provided additional information, noting the five identified principles: Mutual Responsibility, Accountability, Transparency, Equity, and Stability.

Information provided to Premier Wall

Information from the Saskatchewan School Boards Association, relative to facilities funding recommendations and administrative costs of school divisions, had been distributed. Mr. Don Hoium, Director of Education, provided additional information, noting that, on average, Saskatchewan school divisions spend only 2% of their operating budgets on administrative costs and only 0.6% in the area of governance.

Public Engagement Working Advisory Group: Call for Nominations

Information from the Saskatchewan School Boards Association, calling for nominations for the Public Engagement Working Advisory Group, had been distributed. Mr. Don Hoium, Director of Education, provided additional information, noting that expressions of interest should be made by April 3, 2010. Dr. B. Young noted that Mrs. A. Fraser would be putting her name forward for consideration.

Public Section

Information from the Public Section had been distributed. Dr. B. Young reminded Board members of the Public Section General Meeting scheduled for June 3 and 4, 2010, in Regina.

Continuous Improvement Monitoring Conference

A letter from the Acting Director, Continuous Improvement Unit, Ministry of Education, had been distributed. Mr. Don Hoium, Director of Education, provided additional information, highlighting the Ministry's comments regarding the commitment, energy and dedication of the Division's leadership team. The Board expressed appreciation to the members of Administrative Council for their efforts.

Structural Innovation Site Visitations

Information relative to scheduled Board member visitations to Structural Innovation schools had been distributed. Mr. Don Hoium, Director of Education, provided additional information, noting that he would schedule future visitations for Board members unable to attend these visitations.
