Inclusive Education Presentation

Dr. B. Young welcomed Dr. Vianne Timmons, President, University of Regina, to the Board meeting. Dr. Timmons noted that her two main areas of research have been inclusive education and family literacy. She outlined her background working with children with disabilities, and advised that her thesis revolved around the quality of life of children with disabilities and how they are educated. She stated that every child in Canada has the right to go to school and to be educated with his/her age appropriate peers. She did emphasize, however, that inclusion is not only about where a child is educated. She highlighted the importance of teacher education and attitudes. Dr. Timmons advised that inclusive education benefits a broader constituency than just the children with special needs. She referred to the quote, "The quality of education should be measured by the quality of education that we provide for our most vulnerable populations." She congratulated the Board on its commitment to educating more students in their neighbourhood schools. Dr. Timmons responded to questions relative to parental roles, teaching strategies, the role of educational assistants, recommended readings for trustees, and public perception. The Board expressed appreciation for the presentation.

**Public Section** 

Information from the Public Section had been distributed. Dr. B. Young provided additional information, highlighting the branding exercises that were held on October 7 and 19, 2010. She updated Board members relative to mediation discussions. Board members agreed to attend an informal meeting to discuss Public Section matters on November 29, 2010, at 8:45 a.m.

Members' Council Summaries Summaries of reports made at the Members' Council Meeting held October 2010 had been distributed. Mr. Don Hoium, Director of Education, provided additional information relative to the work of the Accountability, Evaluation and Reporting Subcommittee, noting the discussion on the Continuous Improvement Framework. Mrs. C. Anderson provided additional information relative to the progress of the Education Equity Working Advisory Group, advising that boards of education would be invited to contribute information to assist in the development of a resource to serve as a tool for assessing the equity of education funding and for advocating with the Ministry of Education. In relation to the First Nations and Métis Education Working Advisory Group, Dr. B. Young reminded Board members that the Saskatchewan School Boards Association Spring Assembly will be focused on First Nations and Métis education. Mrs. A. Fraser provided additional information relative to the Public Engagement Working Advisory Group, noting the importance of boards working together with school community councils, as well as the positive impact of parent and community involvement and support on student achievement and success, and the need for stronger public recognition of and appreciation for the value of Pre-K-12 education in the Province.

Learning Alliance Meeting Tentative Agenda A tentative agenda for the Learning Alliance meeting to be held on November 28, 2010, had been distributed. Mr. Don Hoium, Director of Education, outlined the substantive topics for discussion, including the Provincial Funding Distribution Model and Public Section developments.

Renewal Planning Wilfrid Walker Single Track French Immersion Program Report A copy of the Renewing Regina Public Schools École Wilfrid Walker Single Track French Immersion Program Report had been distributed. Mr. Mike Walter, Deputy Director, Instruction and School Services, provided an overview of the report. He emphasized that both dual and single track schools in Regina Public are Type B French Immersion Programs. He advised that, from a student achievement perspective, students at the school show appropriate levels of achievement with programming delivered through a single track approach, and concluded that, as demonstrated over the past two years, single track French Immersion programming is a viable option for the Division should enrolment patterns result in the need to merge English program attendance areas. Mr. Don Hoium, Director of Education, and Mr. Walter responded to questions relative to school population, transportation boundaries, resources and personnel. Board members expressed appreciation for the report.

Continuous Improvement Plan Brochure Regina Public Schools' Continuous Improvement Plan 2010-2011 Brochure had been distributed. Mr. Don Hoium, Director of Education, noted that the brochure is published annually and is made available to all Regina Public schools and all partner organizations, as well as being posted on the website. He advised that, should Board members wish to distribute the brochure at School Community Council meetings, they should contact Mrs. Linda Hecker, Executive Assistant.
